- C. 101% Budget Guarantee Resolution: RESOLVED, that the Board of Directors of Interstate 35 Community School District, will levy property taxes for fiscal year 2020-2021 for the regular program budget adjustment as allowed under section 257.14, Code of Iowa. (This will be a maximum of \$11,895.)
- **D.** Audit This is a review of our annual audit.
- **E. FY 21 Certified Budget** The proposed certified budget was published on March 11, 2020. The proposed budget was published at a higher rate (\$18.79794) and that will likely be adjusted down. We publish higher to allow for some minor fluctuation and finalize in June with the Department of Management. In June we will adjust it down to the current tax levy.
- **F. Resolution for Debt Service payment** Resolution Authorizing the Redemption of General Obligation School Bonds, Series 2017, Dated July 25, 2017, Approving the Escrow Agent Agreement, and Levying a Tax for Fiscal Year 2020-21 for the Redemption of General Obligation School Bonds, Series 2017, Dated July 25, 2017
- **G. HR Sharing Agreement with Southeast Warren** This is the agreement for sharing with Southeast Warren for our Human Resources Shared position. We are recommending a two year agreement. We have similar contracts with other districts for transportation, curriculum, and maintenance. Sharing agreements continue to be a great way to offer services for students that may otherwise be cost prohibitive.

#### H. 2019-2020 School Calendar Recommended Change

- 1. Friday, April 10, 2020 Flex Day
- 2. Monday, April 13, 2020 School Day
- 3. May 29, 2020 Last Day of Classes
  - a) Assuming classes resume April 13 we will have missed 16 days of instructional time (14 days for closure, 2 days for weather)
  - b) Each school day is 6.7 hours.
  - c) We started the year with 1147.1 hours
  - d) Moving the last day to May 29, 2020 will get us to 1060 instructional hours (or three days short of the recommended 1080 in a year.)
